CY4GATE HAS BEEN AWARDED NEW CONTRACTS WITH A TOTAL VALUE OF ABOUT € 10 MILLION FOR SOLUTIONS IN DECISION INTELLIGENCE FOR LEADING FOREIGN INSTITUTIONAL CLIENTS

Rome, November 11, 2024 - **CY4GATE (CY4.MI)**, national and European player in cyber security and cyber intelligence, signed in recent weeks two contracts worth a total of about € 10 million with leading institutional customers for the acquisition of solutions in the Decision Intelligence field and for a duration of three years.

The contracts refer to the provision (a) of a Data Fusion Center, based on Quipo technology, which exploits the potential of using various Artificial Intelligence techniques and related proprietary technologies. The Quipo will be verticalized to the specific needs of the client, to integrate several very heterogeneous data sources and to provide decision makers with those summarized information elements that allow timely adoption of expert decisions with the lowest level of risk and (b) of a substantial package of evolutions of the Decision Intelligence platform for institutional use.
